

## Entercom National Text-2-Win Contest Rules

These contest rules are specific to the above contest conducted by the Entercom companies and radio stations listed on Attachment A at the end of these rules (each, a “**Station**” and collectively, the “**Stations**”). A copy of these specific contest rules are available at each of the Stations’ studios during regular business hours and on each of the Stations’ websites. A complete list of addresses and websites for the Stations are listed on Attachment A.

**Notwithstanding anything to the contrary in each Stations’ individual written general contest rules, these official contest rules govern this particular contest in the event of any conflict.**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.**

### Who Can Enter

---

1. Eligible contestants must be 18 years of age or older and legal U.S. residents of one of the forty-eight (48) contiguous United States as of the date of entry in this contest.
2. Employees (including, without limitation, part-time or temporary employees) of the Stations, contest sponsors and their respective parent entities, subsidiaries, affiliated companies and advertising and promotion agencies, and management/tour companies at any time during the applicable contesting period and the immediate family and other household members (*i.e.*, spouses, parents, grandparents, children, grandchildren, roommates, housemates, significant others, partners, siblings (half and full) and the steps of each of the foregoing) of each of the above are NOT eligible to enter and/or to win the Contest.

### How to Enter & How to Win

---

3. To enter, weekdays only from February 25, 2013 at 6:00AM (**Pacific Time**, regardless of the time zone the entrant is located in) through March 29, 2013 at 4:10PM (**Pacific Time**, regardless of the time zone the entrant is located in), listen to one of the participating Stations at approximately 6:00AM, 10:00AM, 1:00PM and 4:00PM (**Pacific Time**, regardless of the time zone the entrant/Station is located in) for the specified contest Keyword. The Keyword may be announced on any particular Station (and vary from Station to Station and from play to play) anywhere between five minutes before the hour until eight minutes after the hour.
4. When the Keyword is announced entrants must text that specific Keyword to shortcode 72881. Entries for each play of the contest will be accepted only until ten minutes after the hour (as applicable: 6:10AM, 10:10AM, 1:10PM and 4:10PM (**Pacific Time**, regardless of the time zone the entrant is located in)). Only texts received at the preceding shortcode are eligible to participate in this contest. Texts to other Station shortcodes will not be valid entries in this contest.
5. The Keyword will be different for each play of the contest (4 plays per contesting weekday).
6. Contestants can enter/text as many times as they like – there is no limit on entries.
7. Following each play of the contest (later that same day), one (1) winner (subject to confirmation of eligibility and compliance with these contest rules) will be randomly selected in a drawing from among all entries received nationally (see below) for that play

- of the contest. There will be a total of up to four (4) national winners daily for each contest weekday.
8. Potential Winner will be notified at the telephone number from which he or she texted the entry from within 24 business hours of being selected.
  9. Any entry texted with an incorrect Keyword for that play of the contest or sent more than ten minutes after the top of the hour for that play of the contest will be automatically disqualified without notice.
  10. Standard message & data rates may apply and fees may apply even for any bounce-back message you receive – check with your carrier before entering.
  11. Entrants may receive bounce back texts from Stations with information about subsequent plays of the contest but they will receive no “extra” information that is not otherwise available to the public.
  12. **WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations. Contest Participants should not rely on streamed broadcasts.**

### **Prize**

13. Up to one-hundred (100) prizes will be awarded in this contest (up to 4 winners per day x 25 contesting weekdays). Each verified Winner(s) in this contest will each receive a \$1,000 company check, which will be mailed to each verified winner within 8 weeks of Stations’ receipt of all required completed documents and information.
14. Notwithstanding anything to the contrary herein or stated on-air, the Winner(s) will not be entitled to receive any prize until after their eligibility has been confirmed or accepted by Station representatives and all required paperwork (including, without limitation, liability release agreements) have been completed by the pending Winner within the required deadlines.
15. Prize will be released to Winner only. Winner is required to present a valid state photo ID and valid social security number in order to be eligible to receive any prize. Winner may be required, in Stations’ sole discretion, to sign one or more a Liability Release Agreements relieving the Stations, Sponsors, and their respective parents, subsidiaries, officers, directors, members, managers, employees, agents from any and all liability with respect to participation in this contest and the receipt and/or use of the prize. Any person who refuses to sign such Releases and/or provide a social security number or complete or provide any other documents required by the Stations by the deadline required by Station representative will forfeit any and all contest prizes. Station reserves the right to examine identification and may reasonably choose to accept or deny awarding the prize based on the identification presented.
16. No transfer or assignment of prizes is allowed.
17. Prize not claimed by the deadline set by the Stations or Sponsors, or in the case of a time sensitive prize, within its period of usability, shall be considered forfeited and will become property of Stations. Such prize may be disposed of at the discretion of Stations’ Management.
18. Winner is responsible for paying all applicable local, county, state and federal taxes on prizes and will be issued an IRS 1099 form for all prizes won in this contest.
19. Stations reserve the right to (but not the obligation) to post some or all winner information on the Stations’ websites or social networking sites.

21. Odds of winning depend upon number of texts received for each play of the contest.

## **Other General Rules that Apply to this Contest**

---

22. Notwithstanding anything to the contrary in these rules or stated on-air or otherwise by the Stations or Sponsors, in no event are the Stations required to confirm eligibility or eliminate ineligible entrants prior to conducting the random drawing. In the event that the selected Winner is determined to be ineligible at any time, he/she will be disqualified and not entitled to any prize in this contest. In such event, Stations randomly select an alternative Winner from among all other entries received, time permitting.
23. All entries become the property of the Stations and will not be acknowledged or returned. Entries received that are mutilated, tampered with, illegible, or from ineligible entrants will be void. Entries that are determined to be fraudulent will be void, and the person making such an entry barred from further participation in that contest and, in Stations' sole discretion on a case by case basis, banned from any future participation in any Stations contest (which Stations decision may not be disputed or appealed). Incomplete or illegible entries may be disqualified in Stations' sole discretion.
24. In case of an identity dispute, the registered user of the text message account on the date of entry will be the recognized user. Participants acknowledge that messages are distributed via third party mobile network providers and, therefore, Station cannot control certain factors relating to message delivery. Participants acknowledge that, depending on the recipient's mobile provider service, it may not be possible to transmit the message to the recipient successfully. Station does not claim or guarantee availability or performance of this service, including liability for transmission delays or message failures. Station does not charge a fee for this service. It is each Participant's responsibility to check with their individual carrier, as other charges may apply. **BE ADVISED THAT IN SOME CASES, TEXTS TO THE STATION WILL RESULT IN ONE OR MORE AUTOMATIC BOUNCE BACK MESSAGES, FOR WHICH PARTICIPANTS MAY INCUR A FEE FROM THEIR PROVIDER.** Station assumes no responsibility for charges incurred for text-messaging, including, without limitation, as a result of any bounce back messages or contest notices from the Station.
25. Use of robotic, mechanical or other forms of pre-programmed entry methods is NOT prohibited. Stations do not intend to monitor or disqualify any contest entry on the basis of the use of such manipulation tools. The decisions of the Station will be final as to all matters, including, without limitation, whether any Keyword texted is correct or not. Entry into the contests constitutes agreement by contestants to abide by these rules, as well as any other rules established by Stations. the "best" or most desirable (based on any lawful criteria Station deems desirable).
27. With respect to notification of potential winners in this contest, Station will only be required to leave one telephone message or send one text message to the number used to enter this contest.

If no answer or answering machine is reached, Station will not be obligated to attempt any further contact. Station reserves the right, in its sole discretion, to attempt to contact any potential winner more than once and shall not be required to attempt to contact all potential winners an equal number of times or in the same communication manner.

32. This contest is subject to all applicable laws and regulations and is void where prohibited.
33. Stations reserves the right to: (i) terminate or declare the Contest null and void and rescind any prize, if in its sole judgment, the rules or the integrity of the Contest have been violated or compromised in any way, intentionally or unintentionally by any person whether or not a participant in the Contest and reserve the right to select a Winner from all eligible uncompromised entries (as it determines in its sole discretion) it received through the date it terminated the Contest; (ii) alter or amend these Contest rules at any time; and (iii) stop or conclude the Contest at any time without prior notice with selecting a Winner from all eligible entries it received up to the time Station concluded the Contest. Material changes to the contest rules will be broadcast on-air, when practical.
34. Participants may be requested to provide Stations or Sponsors with proof that the potential winner is the authorized primary account user of the telephone number associated with the account/submission. Proof of submitting entries will not be deemed to be proof of receipt by Station.

All requests for winner lists must be mailed and received by the Station(s) after the contest is over but prior to six (6) months after the contest has been concluded.
